COMMENTS FROM SENIOR CHAPLAIN STEVE WRIGHT

On May 4th, for the fourth year in a row, the Sacramento Region Community Foundation brought the Big Day of Giving to the Sacramento Region. COMMENTS FROM THE EXECUTIVE DIRECTOR

It was one of those calls to which you never want to dispatch one of your chaplains. Shortly after midnight, a man became enraged and out of control towards another man who had married his ex-wife. He went to the house to confront the man, and when he saw the other man in the road as he drove up to the house, he let his anger boil out of control. He accelerated his vehicle and aimed his car at the man, striking him at a high rate of speed and killing him almost instantly. The Sheriff and Highway Patrol called for my chaplain. They took the wife and her two children to the detectives' office. Obviously, they were traumatized by the horrific events they had witnessed at their home. It was very complicated as the children's father had allegedly just murdered the man married to their mother. The children are young and do not totally understand the situation. The woman dissolved into tears, and as you can expect, she was crying out of control. Our chaplain spent many hours comforting the woman and helping her explain to her young children what had happened. The mother would cycle from anger, to tears, to sorrow, to being stoic and back to tears. Please pray for this woman as she has many complicated issues facing her and her children. Please pray for Chaplain Alan Kushner as he follows up with her and her children.
